Complaints:

The Road Crew has been instructed to not enter fields unless the land is plowed. Also, trapping on private property without the property owner's permission will not be tolerated.

#1 Negotiate and establish the 2002 refuse and recycling fees. Representatives from Waste Management explained the reason for increasing the fees greater than our current contract stipulates is due to the state mandated surcharge on refuse. The surcharge increased from \$.30 to \$3.00 per ton. The proposed rates reflect an 8.8% total increase. Tim Simon motioned to accept the rate increase as proposed by Waste Management, seconded by Ann Simon. Motion carried. Motion carried (3-0). The 2002 rates will be \$72.00 for refuse and bulky waste and \$16.00 for recycling.

#2 Consideration of Ambrose Stephany's petition to rezone the property at W3594 Hwy. 149 from Business-2 to Residential-2. The Plan Commission met on November 12th. The Plan Commission recommended approval of the petition. Jerry Guelig motioned to accept the Plan Commission's recommendation and approve the rezone from B-2 to R-2 as request by Ambrose Stephany, seconded by Ann Simon. Motion carried (3-0).
