- Phase I area is established. However, the District can develop extensions. Interested property-owners were encouraged to contact the Commissioners. It would be more cost effective to construct Phase I and extensions together.
- Resident questioned the options for a failing system outside of Phase I. Replacement or pay for an
 extension.
- Dorothy Pease questioned the timeline for service to Area B. sheer speculation.
- Dan Rosenthal questioned the capacity purchased.
- Dennis Osterholt questioned Decorah Lane not indicating a need. The area was not evaluated.
- Mitch Kahl questioned if the calculations include the rebate expense. No. Attorney St. Peter explained the legalities of the rebate.
- A resident indicated the state's proposed budget includes an exemption to the hook-up requirement if a system if functioning properly. Attorney St. Peter responded that the state code used to require connection within one year. Now it is up to the District to mandate hook-up.
- A resident questioned the projected costs of Phase 2 and 3. Unknown. Rock location and inflation will have an impact.
- Jim Wempner questioned a projection of lateral costs. Lateral connection costs are not included in the assessment amount.
- The group discussed the possibility of building a package plant. The District would have to show compelling reasons to not go to Fond du Lac.
- Mitch Kahl questioned if there is an estimate of collapse costs of existing systems and lateral connection costs. Foth will generate estimates to present at a future meeting.
- Jim Rosenthal asked if the homeowners would have a choice as to the lateral locations. Foth will supply each homeowner with a stake and a letter of explanation. The homeowner should meet with his plumber to determine the best location before indicating the desired location.
- A resident questioned what to do if some of his neighbors don't want the sewer but some do.
 Commission suggested submitting a letter of request for service.

Adolph Schneider motioned to approve the District's Facilities Plan, seconded by Mike Freund. Motion carried (3-0).
