

RESOLUTION NO. 28

WHEREAS, municipalities are required to establish wards in accordance with Section 5.15 of the Wisconsin Statutes following the issuance of a federal decennial census, and

WHEREAS, said decennial census has been issued and the municipality has received a tentative supervisory district plan from Fond du Lac County, and municipalities are required to make a good faith effort to accommodate the tentative plan submitted by the county.

NOW, THEREFORE, BE IT RESOLVED by the Town of Taycheedah that there shall be six wards, the municipal boundaries of which are established as follows:

Ward 1 containing a 2020 population of 947 and comprising the part of tentative supervisory district number 13.

A description of the boundaries of Ward 1, consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: East of US Highway 151, North of County Road WH, North of County Road UU, North of Ledge Road, West of Church Road, South of County Road WH, West of Lakeview Road, South of Silica Road.

Ward 2 containing a 2020 population of 512 and comprising the part of tentative supervisory district number 12.

A description of the boundaries of Ward 2, consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: East of County Road QQ, North of Silica Road, East of Tower Road, then bound by the Town of Taycheedah municipal boundary on the South, East and North.

Ward 3 containing a 2020 population of 965 and comprising the part of tentative supervisory district number 13.

A description of the boundaries of Ward 3, consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: bound by the Town of Taycheedah municipal boundary on the North, West of County Road QQ, North of Silica Road, West of US Highway 151, North of Unnamed Waterway and East of Lake Winnebago.

Ward 4 containing a 2020 population of 919 and comprising the part of tentative supervisory district number 13.

A description of the boundaries of Ward 4, consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: South of Unnamed Waterway, West of US Highway 151, South of County Road WH, South of County Road UU, South of Ledge Road, West of Tower Road, West of the City of Fond du Lac and bound by the Town of Taycheedah municipal boundary on the South, and then North of the City of Fond du Lac, East of Lake Winnebago.

Ward 5 containing a 2020 population of 834 and comprising the part of tentative supervisory district number 13.

A description of the boundaries of Ward 5, consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: South of Silica Road, West of County Road QQ, North of County Road WH and East of Lakeview Road.

Ward 6 containing a 2020 population of 377 and comprising the part of tentative supervisory district number 13.

A description of the boundaries of Ward 6, consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: South of Silica Road, West of Tower Road, North of Ledge Road, East of Church Road, East of County Road QQ.

The polling place for Wards 1 through 6 is hereby designated as follows: Town Hall, W4295 Kiekhaefer Parkway, Fond du Lac, WI 54937.

BE IT FURTHER RESOLVED that there is attached to and made a part of this resolution a map of the Town of Taycheedah, which illustrates the revised boundaries of the above-listed wards.
