## JOHNSBURG SANITARY DISTRICT MONTHLY COMMISSION MEETING DECEMBER 14, 2023 5:00 P.M. TOMMY J'S BAR, JOHNSBURG

Members present: President Franz Schmitz, Commissioners Ken Schneider and Jason Meyer. Also present: Recording Secretary Brenda Schneider, Joyce Schneider and Jolene Meyer.

- 1. <u>Call to order</u>. President Schmitz called the meeting to order at 5:01 p.m.
- 2. <u>Approval of the minutes of the 11/2/2023 meeting</u>. Motion by Ken Schneider, second by Jason Meyer, to approve the minutes of the November 2<sup>nd</sup> monthly meeting. Motion carried (3-0).
- 3. Discussion and possible action regarding operational issues:
  - a. <u>Meter station</u>. Nothing to report at this time.
  - b. <u>Lift Stations</u>. The November pump runtime reports were reviewed.
  - c. <u>Grinder pump stations</u>. Nothing to report at this time.
  - d. <u>Clearwater Inspections</u>. The Commission intends to solicit quotes for televising work, to be done during March or April, of the following areas:
    - County Road W from County Road Q to N8971 County Road W (approx. 4500 ft.),
    - County Road Q from W2628 to W2538 (approx. 1000 ft.), and
    - County Road W downtown Malone (approx. 900 ft.).
    - Other areas maybe added dependent upon cost.

All structures have been inspected with the exception of the Welter house and Johnsburg Athletic Club. Re-inspection follow-up is needed at three homes. Only one cross-connection was found.

- e. <u>Other operational issues</u>. Jeremy Bord has alerted the Commission that he plans to cease providing services to the District effective 12/31/2023. The topic will be discussed during the January meeting.
- 4. <u>Approval of District bills</u>. Motion by Ken Schneider, second by Jason Meyer, to approve the bills (order #84-99), for a total of \$16,531.45, and to authorize the following:
  - Transfer \$17,000.00 from the Operations/User Charge Account to the regular checking account,
  - \$8,050.30 from the Operations/User Charge Account to the Debt Service Account, and
  - Transfer \$1,424.83 from the Operations/User Charge Account to the Reserve for Replacement Account. Motion carried (3-0).
- 5. <u>Schedule the next meeting</u>. The next monthly meeting of the Commission is tentatively scheduled for Thursday, January 4<sup>th</sup>, at 5:00 p.m., at St. John the Baptist Parsonage.
- 6. <u>Adjournment</u>. President Schmitz declared the meeting adjourned at 6:11 p.m.
