**Call to order and Pledge of Allegiance:**

Chairman Steffes called the meeting to order at 7:00pm. The Pledge of Allegiance was recited.

**Approval of Meeting Minutes:**

Motioned by Tim Simon, second by James Rosenthal II to approve the minutes of the October 13, 2025 monthly board meeting. Motion carried (4-0).

**Reports:**

**Park & Rec. Advisory Council:** Randy Rieder informed the board the brush site will be open for the last time this year on Saturday, November 15<sup>th</sup>.

**Road Department Managers Report:** Randy Rieder informed the board the ditches are mowed, and he is preparing everything for the winter season.

**Review Financial Reports:**

Treasurer Katherine Diederich presented the financials and informed the board the final transportation aid was received. There is adequate cash to pay the October invoices.

**Approval of Town Bills:**

Motioned by Justin Fowler, second by Chairman Steffes to approve the bills (order #435-455). Motion carried (4-0).

**New Business:**

1. Feyen Kennel License: Jim Feyen was in attendance to request the renewal of his kennel licenses. No issues or complaints received, and he currently has 12 dogs, which is less than the prior year. Motioned by Justin Fowler, second by James Rosenthal II. Motion carried (4-0).
2. Liquor License: Fishing has no Boundaries: Application was completed for the Boundaries Bash held in February 2026. Motioned by Chairman Steffes, second by Justin Fowler to approve the liquor license. Motion carried (4-0).
3. Holyland Snowfliders: No representation, rescheduled for December meeting.
4. UTV/ATV Routes: Fond du Lac County Highway Committee met in October to discuss opening all county highways to ATV/UTV use. The majority of the members were not in favor and therefore it did not move forward. Sam Kaufman presented Plan B to create connecting county highway routes. This would allow a user to get from one side of the county to the other using a combination of existing municipal approved routes and county connecting routes. Town of Taycheedah was asked to approve a portion of County Road W, starting at Ash Road and ending at County Rd WH. Also, a portion of County Rd WH, starting at Cty UU east to County Rd QQ. Chairman Steffes informed the board Eden Area Trail Runners is willing to pay for the

application fees and signage. Motioned by Tim Simon, second by Justin Fowler to approve. Motion carried (4-0).

5. Fire Departments Calumet and Mt. Calvary: Representation by both fire departments were in attendance. Discussions regarding their budgets, expenses, 2% dues, insurance ratings, truck expenses, fundraising and recruiting. Both fire departments will provide a brief description to seek volunteers that will be included in our tax bills. Contracts will be sent to the Town to include a 2% increase for 2026. Clerk Marcoe will look into advertising their fundraising dates on the calendar per attorney approval.
